## 2. Background

### The Scenario

- © District is making a transport plan
- © District planner has called a village assembly of all stakeholders
- © Goal: to carry out a participatory appraisal of transport demands

# Description of the region

## 🌀 Land and climate

- flat topography
- two rainy seasons → two harvests per year
- moderately fertile soils
- cultivation of millet, maize, bananas and tubers

## 🌀 Demography and economy

- 25-40 inhabitants per sq. km.
- 200 households
- average household size is 5 persons
- high male out-migration because of lack of income alternatives and low agricultural productivity
- mostly subsistence farmers
- no other sources of cash income



## 🌀 Existing infrastructure

- no public facilities in village
- one small shop selling basic products

## 🌀 Market town (3-4 hours walk) has...

- district market
- health station
- church
- agricultural extension office
- transport to regional capital

## Distance to resources & facilities

- water source in rainy season: 20 minutes
- water source in dry season: 40 minutes
- firewood: 80 minutes
- fields: 1 hour
- primary school: 90 minutes
