

- Site Visits and Observation of Sample Kebeles Selected for the Introduction of IMT
- Focus Group Discussion with Women Household Members
- Community Meetings and Discussion (Jointly with Men and Women)
- Meetings and Discussion with Wereda Council and Development Committee
- Meeting and Discussion with Kebele Leaders and with Other Members of the Community
- Discussion and Interview with Owners of Animal Drawn Cart
- Discussion and Interview with Randomly Selected Women and Men
- Carrying Out of Gender Analysis Tools
- Review of Secondary Data

#### 7.3 Selection of the Sample Kebeles

#### The Selection Criteria's Were:

- The Topography and Terrain Condition of the Kebeles for the Use of Animal Drawn Carts.
- The Availability and Accessibility of Road Network in the Kebele.
- The Distance of the Kebele from Major Trade and Market Centers.
- The Availability of Grinding Mills and Other Services Within or in the Nearby Kebeles.
- Proximity from the Trunk Road Network.

- Gender & Household Situation Analysis
- Assessing Existing Road Transport Infrastructure, Experience on Use of IMTs and Pack Animals
